Xiaofeng Ma disclaims beneficial ownership of the securities of the Issuer held by Able Knight Development Limited except to the extent of his pecuniary interests therein, if any.
- Mr. Xiaofeng Ma is the sole director and 100% shareholder of Joingear Limited, a British Virgin Islands company, which owns 18,427,074 Common Shares of the Issuer.
